2024 Rules Quiz

1. Juan Epstein had a fall back in August and injured his left ankle. As part of his treatment, he was told to try bowling left-handed to minimize the stress on his injured ankle. He has bowled 24 consecutive years at the USBC Open Championships. His OC entering average is 181. This season (left-handed) he is averaging 135 and wants USBC to consider granting him average relief for the OC.

What information does he need to provide to Rules for consideration for Average Relief? (Choose all that apply)

- Incorrect This is not an issue subject to a protest. A complaint could be made to the league board or USBC for a violation Of USBC Rule 104e, Item 1b.
- Incorrect If teams bowl against the wrong opponents, the matches/pairings stand as bowled – CAQ 107/1 of USBC Rule 107.
- 5. Correct USBC Rule 119c Forfeitures can be applied for the use of an ineligible player if the games are protested within the timelines of Rule 120.

10. What does the league do to resolve this? (Choose all the apply)

- 1. Incorrect The protest was filed within the time limits of Rule 120 and must be accepted and acted upon.
- 2. Correct This information will be necessary in the event the protest is upheld and the bowlers score is corrected.

- 2. Correct In order to add a squad for the affected teams, USBC must approve the additional date and update the Online Tournament Certification records for the event.

- Incorrect While the association must work with the center on an alternative date, tournament entries cannot be reopened to accept additional entries after the original ending date of the tournament.
- 4. Correct The additional date can only be offered to those entries affected by the center closure and squad cancellation. Entries that are not able to bowl on the rescheduled date are to receive refunds of entry fees paid.
